



He is informed and believes that on 3/18/2013 to 4/2/2013, at the City of Madison, the defendant, against the public health and safety and contrary to the following sections of the Madison General Ordinances:

As owner or operator of the premises located at 3600 Portage Road, Madison, WI:


FIRST COUNT: Permitted building or tract of land to be devoted to a use other than a use permitted within the Agricultural District (failed to discontinue all prohibited uses, including camping, from the Agriculture zoned property at 3600 Portage Road), in violation of Madison General Ordinances Sec. 28.091(1).

The forfeiture upon conviction for a violation of Chapter 28 of the Madison General Ordinances, may be from \$1 to \$1000 per count, per day; plus applicable costs including the penalty assessment, jail assessment, crime laboratories and drug law assessment, any applicable consumer information assessment, any applicable domestic abuse assessment, and court costs under Sec. 814.65(1), Wis. Stats., and any such further relief as the plaintiff may request.
