Dane County, the Clean Lakes Alliance and Yahara WINS funded a compost-study in 2017 to evaluate the benefits and promote the use of compost to reduce phosphorus loss to surface waters in the Yahara Watershed. The first phase of the project focused on working with farmers to create compost. This grant will fund the second phase of the project, with a focus on accurately applying the compost. The grant will require annual reports on the number of acres spread, application rates, evaluation of the impact of applying composted manure instead of commercial fertilizer, and yield comparisons between commercial fertilizer and compost.
